RECORD RETENTION

Our policy is to dispose of our copies of tax returns and workpapers, and other tax information that is more than eight years old.

MVNA IS CONSIDERED A SAFETY NET FOR THESE CLIENTS, MOST OF WHOM ARE UNINSURED OR UNDERINSURED AND LIVE IN ABJECT POVERTY. CERTIFIED PUBLIC HEALTH, REGISTERED, AND LICENSED PRACTICAL NURSES IMPLEMENT AND COORDINATE DOCTORS' ORDERS FOR SPECIALIZED CARE AND PROVIDE EDUCATIONAL SUPPORT ABOUT DISEASE MANAGEMENT, SYMPTOM CONTROL AND MEDICATION MANAGEMENT. MVNA HOME HEALTH NURSES EDUCATE THE CLIENT ON HOW TO PERFORM SELF-CARE WITH TECHNICAL PROCEDURES IF THE CLIENT IS ABLE TO DO SO. OTHER SERVICES INCLUDE PHARMACIST FOR MEDICATION REVIEW; THERAPIES: PHYSICAL, OCCUPATIONAL, AND SPEECH; AND HOME HEALTH AIDES FOR PERSONAL CARE: BATHING, GROOMING, DRESSING AND HOMEMAKING. MVNA HOME HEALTH STAFF PROVIDED 31,752 VISITS SERVING 1,531 CLIENTS IN 2010.

THOUSANDS OF VISITS ARE MADE ANNUALLY TO ASSIST HIGH-RISK PREGNANT WOMEN, WOMEN WITH NEWBORNS, CHRONICALLY ILL CHILDREN, CHILDREN WHO ARE ABUSED OR AT-RISK OF ABUSE, OR SUFFERING FROM LEAD EXPOSURE IN THEIR NEIGHBORHOOD. MVNA IS CONSIDERED A SAFETY-NET FOR MANY OF THESE FAMILIES WHO ARE IN ABJECT POVERTY. MVNA MATERNAL AND CHILD HEALTH STAFF PROVIDED 23,398 VISITS SERVING 5,532 CLIENTS IN 2010.
